Important message from the

Executive Director

This communication is being delivered to every household in the Amsterdam Housing Authority in an effort to educate our residents regarding a potentially serious problem that currently exists. Many of you probably have no idea how serious the issue is or the fact that serious legal consequences can result from these actions. Although the infractions I'm going to address are only being perpetrated by a small percentage of the overall population of our residents, the occurrences are still significant in number and everyone needs to be aware of what's happening. The issue is *housing fraud*.

### What exactly is housing fraud?

Housing Fraud occurs when someone who is receiving federal housing subsidy fails to disclose to the housing authority someone who is residing in the household, and/or fails to disclose income being received by someone residing in the household. The consequences for such actions can be severe.

Section 11 of your lease states the following: "The Housing Authority and the Tenant agree that good cause shall exist for immediate termination of this Lease at any time during the initial term or any renewal term, if the Housing Authority discovers that any member of the household has made a material misrepresentation or omission in connection with an application for housing assistance or any certification or recertification made in connection with the household's housing assistance, including any statement, certification or recertification relating to income, family composition, the background or criminal history of any member of the household, or any other matter affecting the household's eligibility for housing assistance. A misrepresentation or omission shall be considered material, and therefore an appropriate ground for termination of the household's tenancy, if the Housing Authority determines that full and accurate disclosure of the matter would, under applicable law or the policies and procedures of the Housing Authority, have resulted in a determination of ineligibility of the household or any of its members for housing assistance."

So how does this relate to my housing you might ask?

Unfortunately, very often residents submit paperwork to AHA without realizing that they are in fact *offering an instrument for filing* for the receipt of a public benefit (housing subsidy). The criminal charge would be the same for a resident who fails to disclose that someone is residing in their household that is not on the lease.

This is why it is extremely important that whenever you complete paperwork for the AHA that you are completely honest and accurate in doing so because if you fail to list everyone residing in your apartment, it can result in criminal charges. The two most important parts of your paperwork are household information (who lives or "is staying" in the apartment and income information (money from any source, no matter how small or infrequent).

# What are the most common cases of misreporting of information?

One of the most common cases of misreporting of information in the public housing nationwide is the failure to report who is actually living in the apartment. We have seen an increase in these situations at the AHA as well. This is one of the reasons for this communication.

# What's the difference between someone visiting versus residing in my apartment?

If someone is staying in your apartment that does not have their own permanent residence, and they remain with you past the two week visitation period provided in your lease, then they can no longer be considered visiting and are now "residing" in your apartment. If there was a situation that required more than a two week stay, special permission would need to be granted by the housing authority upon written request.

Section 12 of your lease states: "The Tenant may not have overnight guests in the leased premises for more than 14 days each year unless prior written request is made by the Tenant to Management and permission is granted to Tenant by Management.

# So what is the Housing Authority going to do about these situations?

Everyone is in agreement that we can't simply ignore this situation. I am sending this reminder to all residents to insure that anyone who is involved in this type of situation, is aware that the situations described constitutes criminal activity and that the AHA is going to pursue these situations to the fullest extent of the law. I hope that anyone involved in a situation like this, will immediately rectify it by having anyone not on the lease leave the residence immediately. There is an application process to follow if you wish to add someone to your household and applications are available at the office.

Your cooperation is needed in order to make our community a nicer and safer place to live. Everyone needs to pay their fair share of rent by reporting all household members and all household income. There are people in desperate need of housing on our waiting list and to ignore these situations would be unfair to them as well as to the overwhelming majority of residents who abide by the rules.



**Towing** 

We are now strictly enforcing our parking rules. Please make sure that your car has an AHA parking sticker on it, and please inform your visitors and medical professionals of our parking rules. The employee parking lot located on Wall St. across from the Hi Rise is for employees only. Tenants and visitors are not allowed to park in this lot at any time.


We will no longer provide warnings, if someone is parked in our lots illegally, they will be towed at the car owners expense.





### FOB's

Your FOB is assigned to you. Tenants should **not** be letting anyone else use their FOB to enter the building. If you need another FOB for a family member or health care provider you must complete a Tenant Key / Building FOB Access Request Form. Please do not let people into the building unless they are there to visit you personally. Visitors and health care providers need to use the intercom system to gain access to the building. The tenant that they are here to visit must let them in. The security of the building depends on the cooperation of our tenants.

The washing machines in the laundry rooms are high efficiency and use less water, please **do not** add extra water to the machines. The machines do not drain properly when extra water is added.

# April is National Child Abuse Awareness Month

Children are suffering from a hidden epidemic of child abuse and neglect. It's a widespread war against our children that we have the power to stop, and understanding the issue is the first step.

Abuse – the term abuse encompasses the most serious harms committed against children. An "abused child" is a child whose parent or other person legally responsible for his/her care inflicts upon the child serious physical injury, a substantial risk of serious injury, or commits an act of sex abuse against the child.

Maltreatment refers to the quality of care the child is receiving from those responsible for him/her. Maltreatment is when a parent or other person legally responsible for the care of a child harms a child, or places a child in

the danger of harm by failing to exercise the minimum degree of care in providing the child with any of the following: food, clothing, shelter, education or medical care when financially able to do so. Maltreatment can also result from not providing adequate supervision for the child. Further, a child may be abused if a parent engages in excessive use of drugs or alcohol such that it interferes with their ability to adequately supervise the child.

Some signs to look for...

- Injuries such as bruises, cuts, bites, grab marks or burns.
- Aggressive or disruptive behavior
- Withdrawn or emotionless behavior
- Fear of going home or fear of parent(s)
- Any signs of sexual abuse
- Obvious malnourishment, listlessness or fatigue
- Stealing or begging for food
- Lack of personal hygiene, torn or dirty clothes
- Untreated need for glasses, dental care or other medical attention
- Frequent tardiness or absence from school

 Child inappropriately left unattended or without supervision




### First Annual Ward 2 Earth Day Event
